



## Transportation Program

on March 1st, BHDDH and RIPTA launched a pilot program for individuals with developmental disabilities who are currently using Ride and RIPTA buses for transportation from home to a service provider program, work, or to a meaningful activity. *All BHDDH-licensed, developmental disability service providers will be part of this pilot program.*

The program, Coordinated Transportation Exchange (CTE), is part of Governor Raimondo's initiative to improve State services and part of BHDDH's vision to be a leader in the development of innovative programs that improve care delivery, strengthen the service delivery network and best serve those who use the BHDDH system.

BHDDH-funded Ride trips are typically booked independently by an individual or by the service provider. This practice will not change so that information between individuals, service providers and Ride is consistent.

**FOR Ride PARTICIPANTS:** BHDDH trips can be scheduled up to the day before you are due to travel. Standing Orders, which are trips that occur on a daily or weekly basis such as trips to day sites or in some cases work, only need to be scheduled once.

### Reserving a Ride

To make a reservation, call (401) 461-9760 between 8:30 am and 4:30 pm from Monday through Friday. On Saturdays and Sundays, you may make reservations between 8:00 am and 4:00 pm.

In place of RIPTIKs on the Ride van, individuals will be signing a tablet upon entering the van. Please notify RIPTA at (401) 461-9760 if someone cannot sign the tablet.

### Regular Bus Service

Individuals using RIPTA's bus service will be getting free, unlimited passes and will not be required to pay the 50 cent fare when it goes into effect.

**FOR SERVICE PROVIDERS:** Facility administrators or assigned staff will be required to provide Ride with a list of BHDDH-approved travel locations for individuals who are not traveling based on standing orders. A list of those who travel on a FLEX bus or the RIPTA city buses must also be submitted. Finally, you will be tasked with providing Ride a list of customers that travel on FLEX bus or the RIPTA city bus so that no-cost bus passes can be issued to customers on the list.

This pilot program is a work in progress; please rest assured that we will continue to reevaluate it as we go along to make sure that it is meeting your needs.
