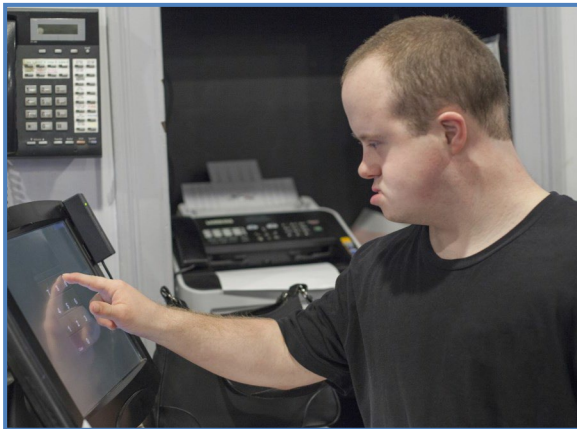


## When the Application is Approved...

# Sherlock Plan

## A Medicaid Program for Working People with Disabilities



Medicaid Coverage

## Description

- ◆ **The Sherlock Plan** is a Medicaid program for working adults with disabilities that provides complete health coverage. The goal is to allow people to keep working and still maintain their health coverage.
- ◆ **There may be a monthly charge based on how much you earn.**
- ◆ If you are offered health insurance coverage through your job you may need to enroll in that plan. DHS may pay the premium.
- ◆ *The Sherlock Plan is a fee-for-service Medicaid plan, not a Managed Care Plan.*



## Long Term Support Services Provided (LTSS)

Services include the full scope of Medicaid benefits. These may include home and community-based services, and services needed to gain and/or maintain employment (clinical review required).

Services are coordinated through the Medicaid Office. Individualized services may be available through BHDDH.

## Who Is Eligible?

Individuals between 19 to 64 years old who have a disability (as defined by Medicaid or the Social Security Administration).

**Must be employed or Self-employed;** no minimum amount of hours is required.

- **Requirements:** DHS will review your income and resources to decide if you meet the standard and if you have a monthly charge (premium). Not all income and resources count when DHS decides if you are eligible. All working adults with disabilities can apply. You may be eligible even if you earn more than \$60,000 per year (2023)!
- **Resources:** Limited to \$10,000 for an individual and \$20,000 for a married couple. Not all resources count.

### Excluded Resources:

- Medical Savings Account, retirement account and ABLE Account.
- Equipment needed for disability; e.g. accessible van, wheel chair, communication device, etc.

## How Do I Apply?

### Get a DHS-2 Application

**In person:** Go to your local DHS Office and request an application.

**Phone:** Call the DHS call center, (855) 697-4347. Ask for an application to be mailed to you.

**Online:** Go to the DHS website, <https://dhs.ri.gov/apply-now>, then scroll to Apply by Mail and download the “DHS-2 Application for Assistance.”

**Submit Forms:** Mail completed DHS-2 Form to address noted on the application instructions or drop off at a local DHS office.

### DHS-2 APPLICATION Sherlock Plan TIPS!

1. Complete Page 1 of the Application. Circle the **Working Adults with Disabilities/Sherlock Plan**, also Write Sherlock at the top.

**[ ] EAD MEDICAID HEALTH COVERAGE FOR AGE 65 AND OVER, BLIND OR DISABLED OR PERSONS WITH DISABILITIES AND WORKING ADULTS WITH DISABILITIES/SHERLOCK PLAN (EAD)**

**[ ] (if applicable) LTSS - MEDICAID: LONG-TERM SERVICES AND SUPPORTS (LTSS)**

2. Complete the related EAD or LTSS sections.

3. **Request a delivery receipt** from the Post Office or drop off location if delivered in person. Contact DHS after 30 days if no reply.
