VARIANCE PROCESS

- 1. Before submitting a Request for a Variance, check that all sections of the form are completed. Incomplete forms will not be processed.
- 2. Please send the form by mail or secure mail to the Division of Developmental Disabilities:

 - Email: Gerard.MacKay@bhddh.ri.gov (see secure email instructions on nextpage)
- 3. DDD will review the Request for completeness.



- 4. The Court Monitor will determine whether a variance is appropriate.
 - a. The Monitor may ask for more information.
 - b. The Monitor may want to meet with you and/or your family, caregiver or guardian to talk about the request for a variance.
- 5. The Court Monitor will let you know his decision within 30 days of receiving the Requestfor a Variance and all supporting documentation.
- 6. If you are granted a variance, you must be reassessed by a qualified professional and have your employment goal re-evaluated within 6 months from the date the variance is granted.
- 7. If you are granted a variance, each year at your annual planning meeting you will discuss if you want to keep the variance or if you would like to get a job.
- 8. At any time, you can change your mind and cancel the variance and choose to receive supported employment services in a competitive, integrated job. If you change your mind, let your DD social caseworker and your provider know.

email address.

If the user has already registered with Proofpoint Encryption, the user will be prompted to provide a password to authenticate before they can compose a secure message.

If the user has not already registered with Proofpoint Encryption, the user is prompted to create an account. The user will then receive a email confirmation to complete the registration process.

Important: For security reasons, registering, authenticating, and composing secure messages with Proofpoint Encryption must be completed in the same browser, on the same system, within a 30-minute period.

Users can compose a message to internal State Employees, as well as attach files to the email. The attachments do not need to be encrypted as the connection between the external user and the State Secure Email Portal is encrypted.
